I/We also agree that the venue of any action against me/us will at the option of Supplier be either in the courts of the state and county where Supplier branch that supplies the Customer is located or where the Customer's business is located. I/We also agree to be joined as additional parties to any arbitration convened under any arbitration agreement between Customer and Supplier. All amendments hereto and the waiver of any rights granted hereunder shall be in writing, signed by the parties. This guaranty shall be governed by the laws of the state where Supplier's branch supplying the Customer is located. Time is of the essence in performing all of the terms of this guaranty. If an arbitrator or court with jurisdiction determines that any term of this guaranty is unenforceable, the other terms shall remain in full force and effect. This guaranty shall bind and benefit the heirs, successors and assigns of the parties. If there is more than one guarantor, their liability shall be joint and several. This guaranty shall be construed according to its fair meaning and not for or against any party.
